Minutes of November 16, 2023, Interior Decorating and Ballroom Committee Meeting

1. Call to Order

The meeting was called to order by Ray Panknin, committee chair, at 2:00 PM.

2. Proof of Notice

Notice of the meeting was given in accordance with statute and board direction.

3. Roll Call

A quorum of the committee (Ray Panknin, Chair; Jessie Schminke; Jim Geis; Vicki Hughes) was present in person.

4. Approval of Minutes

a. October 17, 2023

A motion was made by Jim Geis, seconded by Vicki Hughes, and approved unanimously to accept the October 17, 2023, committee meeting minutes as written.

5. Atrium Flooring

After extensive discussion, a motion was made by Jim Geis, seconded by Vicki Hughes, and approved unanimously to recommend an association atrium flooring policy that calls for replacements consisting of commercial grade, indoor/outdoor, Nylon carpet with 4-6" carpeted baseboard to match if there are no existing wood baseboards. If owners of a particular floor want to upgrade their flooring beyond the standard set by the association, those owners will be responsible for paying for the difference in price between the association standard and their desired replacement.

6. Upholstering Priorities

After discussion, it was determined that the next needed area of upholstery work was the couches in the ballroom as these are the most visible to residents and visitors. As these couches appear to be of good quality, management was asked to get pricing for reupholstering these couches as a comparison to replacement.

7. 2nd Floor Meeting Room & Billard Room Window Covering

Mary West presented several concerns with the blackout shades previously recommended for the 2nd floor meeting room. After discussion, the committee recommended replacement with White light filtering blinds matching those in the cardroom and lounge. The committee further asked that pricing be gotten on a side sliding version of a similar blind for the sliding glass door.

8. Adjournment

With no further business to come before the committee, the meeting was adjourned at 2:55 PM.

Atrium Flooring – 5th Floor North

At our last Decorating & Ballroom meeting a lengthy discussion was held concerning the recommended atrium flooring policy for OHC. The committee eventually unanimously recommended:

replacements consisting of commercial grade, indoor/outdoor, Nylon carpet with 4-6" carpeted baseboard to match if there are no existing wood baseboards. If owners of a particular floor want to upgrade their flooring beyond the standard set by the association, those owners will be responsible for paying for the difference in price between the association standard and their desired replacement.

The board has not yet acted upon this recommendation, but the owners on the 5th floor, North Tower have expressed a desire to have their flooring replaced. They have supplied proposals from Rod's Carpet and Georgia Floors for carpeting and LVP options. These proposals are appended for your review. Their preference is for the LVP option. A proposal in accordance with the committee's previous recommendation has also been obtained and appended from Discount Carpet. Proposal price comparisons are supplied below:

Samples of the various flooring Based on the previous recommendation, if it is determined that the flooring needs replaced, the association would contribute \$3,842.00 with the owners making up the difference.

We have previously discussed concerns with hard flooring material being used in atriums. While there are various carpets in the North Tower that appear dated, they are still in relatively good shape. The 5th Floor North falls into this category. Recommendations to the board from the various committees are requested.
